Children are referred by teachers, nurses or counselors and brought to "shop" at our facility. The goal of this program is to strengthen self-confidence and inspire scholastic achievement in disadvantaged children. Approximately 1,195 students were assisted with 41 schools participating during the 2024-2025 year.
